

## Terms of Use

Last Revised October 5, 2006.

1. Acceptance of Terms of Use. BiMedical.net, LLC (“BiMedical”) maintains this web site (the “Site”) for personal information and use by you, on the part of both you and any individual or business entity on behalf of whom (or which) you use the software (collectively, “You”).
